# **ELECTION'S PROCEDURE FOR DIRECTORS**

# CANDIDATES WANTED FOR FOUR POSITIONS

As stipulated by articles 4.7, 5.2 and 5.3 of the Constitution, each member that wants to propose a candidate, other than those mentioned above, can do so by communicating with the Association at least forty five (45) days before the Annual general meeting, so **before Tuesday July 5, 2018**.

Candidates nominated for directorship positions on the association's board must be supported by the signatures of five (5) active members of the QPMA, performing as senior executives, and representing five (5) different companies, having their business place in Quebec. To demonstrate a commitment to the QPMA membership, the five (5) signatures must be handwritten / physical. The candidate must also send his application letter.

This year, **four (4) positions** are open from different sectors:

- Grower packer processor- shipper (1)
- Wholesaler importer –exporter (1)
- Wholesaler, retail and food distribution (1)
- Fruit store (1)

in keeping with our principle of membership representation by sector of activity.

### Note for the potential candidates:

Once the applications received, the candidates will be contacted for an information session. They will be advised about the election's procedure, the director's role and involvement.

### **RENEWED MANDATES**

The nomination committee of the Association advises you the list of directors whose mandate's term expires on August 17, 2018 and renew them for the next 2 years until August 2020.

## WHAT DOES A DIRECTOR DO?



The board of directors is responsible for the QPMA mission and values. In the final analysis, the board reports to the association despite the fact that it delegates management authority of the organization to the CEO and the executive committee

The directors must ensure that QPMA activities meet set objectives. They adopt a budget and policies that will frame the work of the management team in order to ensure that the competence and integrity of the team are maintained. They contribute to the improvement of operational plans and offer their network of contacts to help in raising funds and building partnerships

### More specifically, the role of a director is to:

- Become familiar with the rules of the association.
- Make sure the rules are up to date.
- Be a spokesperson for QPMA values and working to accomplish its mission
- Attend meetings regularly and exercise their right to speak.
- Attend regularly the QPPMA meetings and exercising his spoken right :
  - Participate at Annual General Meeting
  - Attend Special Meetings
  - Attend Board Meetings: October, November, March and August.
  - Attend and bring his expertise Committee Meetings :
    - Government Relations and Public Affairs,
    - Promotion of Fruits and Vegetable, "I Love " Campaign,
    - Member Services, Internal Communications and Events,
    - Various networking activities,
    - Next generation,
    - Working groups,
    - Sectorial committees.
- Be prepared to occupy the 2nd vice-president, 1st vice-president, president and past president title
- Recruit:
  - new members.
  - sponsors for networking activities,
  - advertisers for the Yearbook.
- Promote the "I love 5 to 10 servings a day" campaign and its contest.
